HIGHLIGHTS

The 4-day PAEPI Biennial Convention with the theme "Implementation of Research-Based Extension Program Towards Attainment of MDGs Cum Policy Advocacy on Magna Carta for Extension Workers" and 19th General Assembly on December 8-11, 2010 with Aklan State University as host and organizer, in cooperation with MAAP and PAEPI as co-organizers, is enriched with the support of two prominent keynote speakers: former CHED Commissioner Dr. Roberto S Padua, an International Research Awardee, for the PAEPI advocacy of Implementing a Research-based extension services program in the accomplishment of MDGs and Hon. Cong. Eulogio "Amang" R. Magsaysay, Jr., AVE Party List Secretary-General, for the PAEPI Policy advocacy for "Magna Carta for Extension Services Workers".

PROGRAM OUTLINE

Part 1- The Presidents' Night Program

In honor of the founder, PAEPI led by the Technological University of the Philippines (TUP) duly represented by its President Dr. Olympio V Caparas. All deserving PAEPIANS, BODs, past presidents and active members are recognized which is timely as it coincides with the PAEPI 20th anniversary. Project partners are also honored with signing of the MOU beneficial for PAEPI members.

Part 2 - The Opening Program

During the first day of the convention, all participants will convene at the plenary hall for the opening ceremonies and plenary sessions with the First Keynote speaker as GOH. In the afternoon, the participants will go to their respective field of interest in terms of extension services development areas:

- 1. Socio-welfare Development
- 2. Socio-economic Development
- 3. Infrastructure / Technology Development
- 4. Health/Safety and Environmental Development,

Out of 39 papers submitted, 25 full papers were short-listed as entry for the best paper category. There are 4 papers to be presented in the plenary session and 30 papers to be presented in the 4 cluster sessions. Some of the papers were also entered for the best poster contest to be posted in the exhibit area. Only one best paper presented will be adjudged the winner per cluster based on set PAEPI criteria of gathering at least 80 points.

Paper must have followed the guidelines in its preparation based on the theme, with emphasis on what Millennium development Goals (MDGs) have been accomplished by the extension services program /practices. MDGs refer to the 8 goals and 18 targets set during the 2005 World Summit in response to the world's main development changes. Derived from the original chapters of the UN Millennium Declaration of 2001, this international development blueprint aims to reduce global poverty, hunger, diseases, illiteracy, environmental

degradation and discrimination against woman in 2015.

PAEPI, through this convention, provided a venue for its members to presents/share accomplishments and for documentation and recognition of their efforts as part of "PAEPI advocacy initiatives towards MDGs Accomplishment: A Development Intervention in terms of extension delivery", a paper to be presented by the PAEPI President at the plenary Session.

Part 3. The PAEPI Advocacy Policy Program

Magna Carta For Extension Workers shall be presented once again to the body as supported by Hon. Cong Amang Magsaysay Jr, Guest of Honor and Keynote speaker of the day.

Part 4. The General Assembly Program

All the policies, forms, procedures shall be presented to the body for the approval of the general membership. A comprehensive PAEPI biennial report shall also be presented by the outgoing President and the financial standing of PAEPI shall be reported by the PAEPI Treasurer.

Part 5. The Closing Program

Oath taking of new members and officers shall be officiated by the outgoing President. Awarding ceremonies also follows to recognize all the participants, paper presenters , the board of judges, committee chairs and all those who make the activity as success.

THE ROLE OF RESEARCH IN EXTENSION PROGRAMS OF HIGHER EDUCATION INSTITUTIONS

Fellow Academicians:

It is truly an honor to provide the keynote to this annual conference of the PAEPI particularly in light of the interest shown in linking research and extension in higher education.

The traditional functions of all higher education institutions in the world have been to engage in only two things: instruction and research. This tradition stems from the original conception of an academe by Plato as a "source and dispenser of knowledge" for society. Research is the function which provides new knowledge while instruction is the higher education function which transmits this knowledge to the new generation. In effect, the very act of providing instruction already constitutes academe's contribution to society at large, that is, instruction was thought of as an "extension" of the academe to the community. The addition of "extension" as yet another distinct function of all higher education institutions is a relatively young development in higher education circa 1970's. Sometime in the late 1990's, another function was added, the function of "production".

The rapid accretion of more functions in the academe can be largely attributed to the growing sense of utilitarianism of society in general, and governments in particular. According to this philosophy, every functioning entity in the scheme of things must be made useful: a truly dangerous proposition. Over the last 1,970 years there were only two higher education functions, then over the last 40 years, this became three higher education functions; and now, over the last 10 years, there are four higher education functions. Recent developments tend to indicate the addition of another function to the already overloaded academe: "External Linkages", which is different from "Extension". I predict that by 2015, the academe will have five (5) official functions: instruction, research, extension, production, and external linkages. Thereafter, before 2010, you will be tasked to perform six functions, seven functions and so on, in a geometrically increasing scale! The troubling aspect of these developments is the fact that the academe's resources remain the same which will be continuously spread across more and more functions. The same thing is happening in our basic education: we use to have only 4 subjects in elementary schools (from 1900 to 1960), namely, reading and writing, arithmetic, science and good manners and right conduct (GRMC). Subsequently, the number of subjects increased by at least one more subject (one addition per new Secretary of Education) until we now find that our kids are saddled with so many things to deal with ultimately, learning so little in basic education.

The natural response to such a development is to amalgamate or integrate or in the language of bureaucracy, "rationalize" the functions. This is the reason why we need to examine closely the intimate connection of "research" and "extension" in the academe.

What Should Be "Extended" by the Academe?

In many cases, the academe's response to the requirement for "extension" in accreditation is to embark on any activity to help surrounding communities. One funny instance that I personally observed was a College of Nursing embarking on an extension project in a barangay teaching the people there how to raise pigs and thereafter, teaching them how to prepare "tocino" and "longaniza": never mind if eating too much "pork" leads to hypertension, and other diseases. What was worse was the fact that the accreditors praised the extension project because it alleviated poverty in the barangay! I am sure that you also have your own funny experiences like this one so that if we collect all of them, we can write a funny book on extension.

What then should our criteria be for developing extension projects in our respective schools? An extension project must:

- · Respond to a felt community need or gap;
- Make use of a technology or knowledge present in the University relevant to the distinctive academic competence of the university or a unit of the university; and
- Make the community more empowered.

Notice that our criteria uses the connective "and". This means all three must be present in an "extension project". In the case of our College of Nursing example, we find that the project responds to (1) and (3) but not (2).

Research and Extension Connection

Criterion (2) above squarely places research in the context of the university's extension program. Extension programs can be conceived out of the results of university researches. Applied research, in particular, normally gives birth to a new technology (in a broad sense) and such a technology can then be transferred to the community (technology-transfer).

Research plays yet another important role in extension. It should be used as a basis for conducting an extension project in a community. The University does a "needs analysis" for a particular target community and then, uses the results of the needs analysis to research on the proper matching of the University's capabilities to respond to the identified gaps in the needs analysis. Just as we have a research framework, we also need an extension framework from which we can draw a rationale system for conducting our extension programs.

To illustrate the point more clearly, extension programs that deal with Literacy Projects for a particular community should not overlap with the mandates of government agencies responsible for such e.g. Department of Education and Department of Social Welfare Development. Here is where research should come in: what aspects of community literacy have not been responded to by these government agencies and where can the University come in? Similarly, projects on Community Poverty Alleviation should undergo a similar research-driven extension protocol because Poverty Alleviation is a central mandate of the National Poverty Commission and the Department of Social Welfare and Development.

A paradigm such as this also requires that accrediting bodies do not merely go through the motion of "counting" the number of extension projects per university program. They should look for the research bases of the extension projects presented by the University and should be convinced that indeed such extension projects respond to a gap which is not satisfactorily addressed by responsible government agencies. University extension projects that overlap with the mandates of responsible government agencies cost millions of pesos when we account for them across all higher education institutions in the country. A very rough approximation to such a wastage can be had by considering a very conservative estimate per college/university at P50,000 per extension project undertaken by a university which overlaps with the mandates of other government agencies. Multiply this by 1,700 higher education institutions and you have a whooping P85,000,000 (eighty five million pesos) wasted investment for the entire nation.

The Philippine Commission on Higher Education has a program called Best Higher Education Institution Extension Program and some of you may have participated in this competition. The main criteria for this CHED-sponsored competition is IMPACT to the community. I, personally, would have wanted the criterion of being research-based inserted as a main criterion for this competition because an extension project may truly have a huge socio-economic impact to the community but if it overlaps with what other government agencies are doing, then it is a difficult matter to attribute the IMPACT to the university's extension project: what percentage of that impact is due to the university and what percentage is due to the other agencies?

Concluding Remarks

The University's extension function is a function that intimately relates with the two other functions of instruction and research.

All extension programs of the university should be research-based because only through research can we be assured that our extension projects respond to a need that is not addressed by other entities of the government.

We can only extend to the community if we have something to extend in the first place. It is therefore imperative that we also ensure that the two other functions: research and instruction, are already stable and that we can lay claim to a distinctive area of competence prior to the conduct of an extension project.
